



## ONE ATLANTA BASKETBALL WAIVER 2020

I/We the undersigned hereby certify that I (we) am (are) the parent(s) or legal guardian(s) of the athlete... In consideration of participating in ONE Atlanta Basketball activities such as camps, training, workouts, etc. I (we) represent that I (we) understand the nature of these activities and that I (my child) am qualified, in good health, and in proper physical condition to participate in such activity. I (we) acknowledge that if I (we) believe event conditions are unsafe, I will immediately discontinue participation in the activity.

I (we) fully understand that these activities involve risk of serious bodily injury, including permanent disability, paralysis and death, which may be caused by the athlete's own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "Releasees" named below; and that there may be other risks either not known to me or readily foreseeable at this time; and I (we) fully accept and assume all such risks and all responsibility for losses, costs, and damages incurred as a result of my (the athlete's) participation in the activity.

I (We) hereby release, discharge, and covenant not to sue ONE Atlanta Basketball, Peachtree Road United Methodist Church (PRUMC), Agape Youth and Family Center, their respective administrators, directors, board members, agents, officers, volunteers, and employees and coaches, other participants, any sponsors, advertisers, and, if applicable, other owners and lessors of premises on which the activity takes place, (each considered one of the "Releasees" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence if the Releasees or otherwise, including negligent operations; and I (we) further agree that if, despite this RELEASE AND WAIVER OF LIABILITY ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, I (we), or anyone on our behalf, makes a claim against any of the Releasees, I (we) will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost which any may incur as the result of such claim.

### Specific COVID-19 Issues

ONE Atlanta Basketball is doing everything in its power to protect the instructor and other participants in its sponsored activities. To this extent, we will be following the Center of Disease Control (CDC) and the State of Georgia Health Department guidelines with regard to safe practices in order to reduce the spread of COVID-19. This will require our staff and participants to abide by the following:

In this new age, at least for now, One Atlanta basketball will be following health protocols recommended by CDC and other relevant regulatory approved sources. These will be, though not limited to, the following:

1. Signage will be posted at entrances and exits indicating One Atlanta Basketball, PRUMC, and Agape are invested in following the correct health protocols. These signs will clearly state one cannot gain entry if you have COVID-19, are experiencing symptoms of COVID-19, or if you or any of your friends or family members have been exposed to COVID -19.
2. Coaches and staff members will have their temperatures taken prior to their beginning work.
3. All players will have their temperature taken upon checking in for camp sessions.
4. All players must sanitize their hands at check in, prior to entry.
5. After cleaning their hands, players must place their bag and personal items in a designated area allowing at least 6' between everybody else's personal items.
6. Coaches will sanitize their hands prior to beginning to work, and will sanitize their hands multiple times during training sessions.
7. Players will sanitize their hands multiple times during their training session. Hand cleaning stations will be in place near the court.
8. There will be no use of the water fountain during these training sessions. Use of the on site water fountain will resume when medical guidelines permit this kind of activity. Athletes must bring their own water or other liquids to drink during training.
9. Coaches and staff members will closely monitor all players at all times.
10. At the end of the training session players and coaches will cooperate in the cleaning of their assigned balls, and any other training equipment utilized.
11. Bathroom facilities will be frequently sanitized and cleaned.
12. Initially, no spectators will be allowed on or near the courts. Parents/Guardians will check their athlete in and return to pick-up their athlete after the camp session has ended.
13. Athletes will enter and exit through the designated areas only.

It is REQUIRED for everyone to either wash or sanitize their hands after using the restroom, sneezing, coughing, and before participating in any activity.
